**Deputation:** Officers under the Central Government or State Government or Union Territories or Public Sector Undertakings or Agricultural Universities or Recognised Research Institutions or Semi Government Statutory Autonomous Organisations:-

- (a) (i) Holding analogous posts in the 'Stenographer's cadre on regular basis in the parent cadre or department or
  - (ii) With five years' service in the Stenographer's cadre rendered after appointment thereto on a regular basis in Level-6, Rs.35400-112400/- or equivalent in the parent cadre or Department.
- **Note 1**:- Officers of only Central Government or State Government or Union Territories shall be eligible for consideration for appointment on absorption basis. Period of deputation (including short term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organisation or Department of the Central Government shall ordinarily not exceed three years. The maximum age limit for appointment by deputation (including short term contract) shall not be exceeding 56 years as on the closing date of receipt of application.
- **Note 2**: For the purpose of appointment on deputation or absorption basis, the service rendered on a regular basis by an officer prior to 1<sup>st</sup> January, 2016/ the date from which the revised pay structure based on 7<sup>th</sup> Central Pay Commission recommendations has been extended shall be deemed to be service rendered in the corresponding level in the pay matrix extended based on the recommendations of the said pay Commission.
