Seed Inspectors /Seed Law Enforcement Officers, 2. Seed Certification Officers and 3. Seed Testing Laboratory Staff. The details of National Training Courses are given as below:

You are requested to send nominations of 2-3 officials from your department/organization on or before the last date of registration. Each training course is limited to 30 participants. The candidates will be selected on the basis of eligibility and will be communicated accordingly.

The selected candidates shall bring proper relieving order from their Department/ organization. NSRTC will provide working lunch and session tea during training programme and the participants has to bear other expenses for attending the training course. During training course, participants will get opportunity to share their experiences with co-participants and therefore, they should bring relevant material in electronic form for discussion during the training period. The officers/officials involved in Seed Law Enforcement , Seed Certification and Seed Testing can apply for the participation in the attached registration form (separate form for each training) and send short curriculum vitae about their working experience and technical duties which they perform in their laboratory/ working places.
